I hereby agree to breed my mare _____ Reg. No. _____

To Lena Red Pep for the _____ season at _____. A _____ non-refundable booking fee, payable to Rocky Mountain Quarter Horses will hold the right of the mare owner to one breeding during the _____ breeding season. The balance of the Stallion fee of _____ will be due upon departure of the mare from breeding facility and or before any semen will be shipped. No mare will be bred before the booking fee is paid and a copy of mare's registration papers (front and back) and a completed contract is on file.

(2. A live foal is guaranteed with return privilege the following 2 seasons by stallion owner only if mare fails to produce a live foal after being sent home in foal, or from shipped semen and checked in foal after 30 days by licensed veterinarian (must send statement to stallion owner). It is understood that if the foal dies before 30 days of age, mare owner will be entitled to a return privilege the following year. This guarantee applies only if mare owner notifies stallion owner within one week from death of a foal. This notice must be accompanied by a statement from a licensed veterinarian. If the mare is to be returned and the mare owner fails to deliver her for rebreeding the following year, then any and all fees shall not be refundable and this contract is thereby cancelled. If the mare should fail to become pregnant, lose the pregnancy or the foal dies, if the mare dies or becomes unfit for breeding, the owner may return the following year with a substitute mare, approved in advance, by the stallion owner.

(3. Diligent efforts will be made to impregnate the mare. However, if for any reason she does not become pregnant, the mare owner will not hold the stallion owner and or their representatives liable. The breeding season will start _____ and close _____. Mare owner agrees to leave mare at _____ until mare has had a 30 - 40 day positive pregnancy exam or otherwise agreed to by mare owner and _____.

(4. It is understood that should the above named stallion die, or become unfit for service, this contract shall become null and void and the breeder's fee will be refunded.

(5. A Breeder's Certificate will be issued upon notification of the birth of the foal by the stallion owner.

(6. Mare owner understands and agrees that stallion owner, _____ and / or their representatives will not be held responsible for accidents, sickness or death to the mare and/or foal. Furthermore, mare owner agrees that the above-named parties shall not be held liable for any negligence or errors and that the above named parties may exercise their judgment in supervising and caring for mares and foals. The above named parties assume no liability for mare owners.

(7. If this contract is for transported cooled semen, a transported semen information form must be completed and returned to _____ prior to the first shipment of semen. In addition, the stallion fee payable to the stallion owner is due in full, along with the transported semen fee payable to _____ before shipment.
